

Tournament Rules:

1. Each skater must have a light or white jersey and a dark or black jersey.
2. Each team must provide a parent or other adult to act as a team manager or coach, for each game.
3. Games are two 13 minute periods with a 2 minute warm-up and a 1 minute rest period between periods.
4. Goalies are registered separately. **Teams are encouraged to bring goalies, but they will have their own game schedule.** Goalies will play one period for each team per game.
5. **No checking permitted!** Checking is a minor penalty. If a player is a problem, a major penalty will be assessed. 3 on 3 is a skills game.
6. All minor penalties will result in a penalty shot for the opposing team.
7. All major penalties will result in a three-minute time penalty and tournament disqualification.
8. Any fighting whatsoever will result in tournament disqualification.
9. USA Hockey rules apply in all other game circumstances, except icing.
10. The number of teams registered will determine how many divisions and teams per division. A round robin within each division will be conducted. The Champion will be determined by points:
WIN = 2 POINTS
TIE = 1 POINTS
LOSS = 0 POINTS

When breaking a tie the following criteria will be used:

1. Total Points
2. Head to Head
3. Goals for and Goals against differential

1. Each skater must have a light or white jersey and a dark or black jersey.
2. Each team must provide a parent or other adult to act as a team manager or coach, for each game.
3. Teams will play a minimum of 4 games. Teams will be made up of 6 players, a goalie (we provide) will play one period for each team if there are not enough goalies the game will be played with no goalies.
4. Games are two 13 minute periods with a 2 minute warm-up and a 1 minute rest period between periods.
5. Squirts and Peewees will Play Cross Ice. Bantams will play Full Ice if there are two goalies and Half Ice with touch up on Blue line if not.
6. All players are registered separately and assigned to team by level of play from last season. **Goalies will be registered as individuals, but they will have their own game schedule.** Goalies will play one period for each team per game.
7. **No checking permitted!** Checking is a minor penalty. If a player is a problem, a major penalty will be assessed. 3 on 3 is a skills game.
8. All minor penalties will result in a penalty shot for the opposing team.
9. All major penalties will result in a three-minute time penalty and tournament disqualification.
10. Any fighting whatsoever will result in tournament disqualification.
11. USA Hockey rules apply in all other game circumstances, except icing.
12. All players must be USA Hockey registered.
13. The number of teams registered will determine how many divisions and teams per division. Ideally a round robin within each division will be conducted with two to four teams advancing to a single elimination play-off round.

LOSS = 0 POINTS
